(Grand)Parent Sponsorship

- Troublesome (pension contribution, economic cost of the PGP coming to Canada, emotional needs)
 - A 10-year waiting period in queue
 - Pause
 - First come, first served
 - Lottery

- What problems can you foresee with such systems?

Sponsoring Parents and Grandparents

- Ability to support (grand)parents and their family members financially
- Grand(parents) are not expected to work to support themselves

The Sponsor's requirements

- R130(1)
 - 18 years +
 - Reside in Canada
 - File an application as per R10
 - Sign an undertaking –
R132(1)(iv)
 - Have financial means
- R133(1)
 - Not a subject to a removal order
 - Not detained
 - Not convicted under the
Criminal Code
 - Non repayment of an
immigration loan or support
payments
 - Etc.

Income required for the 3 tax years right before the day you apply (sponsors applying in 2021)

Total number of people you'll be responsible for	2020 ¹	2019 ¹	2018 ¹
2 people	\$32,899	\$41,007	\$40,379
3 people	\$40,445	\$50,414	\$49,641
4 people	\$49,106	\$61,209	\$60,271
5 people	\$55,695	\$69,423	68,358
6 people	\$62,814	\$78,296	\$77,095
7 people	\$69,935	\$87,172	\$85,835
If more than 7 people, for each additional person, add:	\$7,121	\$8,876	\$8,740

The Sponsor's requirements

- R130(1)
- R117(1)(c)(d) – Sponsor's mother/father or mother/father of the sponsor's mother or father

The Sponsored Parents and/or Grandparents

- No age limit, language or work experience
- Must be admissible
- Provide – Biometrics, Fingerprints/police certificates, medical

- No exemption under A38(2)

2020 interest to sponsor form



2020 interest to sponsor form

The interest to sponsor form was posted on IRCC website for a specific period of time from:

- noon EDT on October 13, 2020 until
- noon EST on November 3, 2020.

- Successful applicants were notified between January 4-8, 2021
- Cap of 10,000 applications

Once invited...

- Apply within 60 days
- NOAs for 2018 and 2019
- Apply early and avoid disappointment

- H&C – The lonely family left behind

Sole PR/Canadian can apply for parents

- Parents are not coming to Canada to work and support themselves, per se

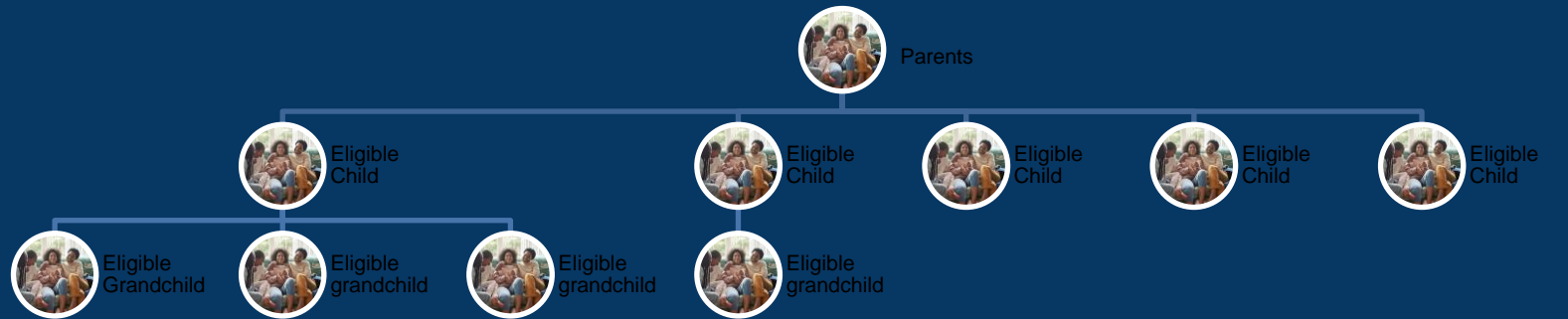
